

GENERAL CONDITIONS OF THE CAMPAIGN PASSE CARTÃO A UM VERÃO TOP

1. This Campaign (in short, Passe Cartão a um verão TOP, or the Campaign) will run from April 18th to August 31st, 2022.
2. The Contest is open to all ActivoBank Clients, new or current, aged 18 years old or older, if they are first demand Account holders and that they meet at least one of the following criteria:
 - Are ActivoBank Customers with an active Classic Credit Card
 - They are ActivoBank Customers with an active AB Gold Credit Card
 Each Customer eligible for the draws will be assigned a few access tickets to the draws, cumulatively, according to the fulfillment of the criteria as per the table below:

Access Criteria	No. of entries for draws	Deadline for meeting the criteria

AB Gold: €100 on purchases	2	

3. Exclusions from the Campaign:

Clients will not be admitted to the draw who, on the date of the draw or until the date on which they claim the prize, have attachment, garnishment, or any other measure of judicial seizure incident to salaries pensions or pensions credited through the Bank or on balances or amounts registered in bank accounts where the Customer is the holder or joint holder, or breach of any credit agreements entered into with the Bank or a record of cheques drawn by the Customer on any account where the Customer is the holder or joint holder or notification made to the Bank of the inhibition of the use of a cheque by the holder.
4. Drawing process:

The Bank will verify if the Customers meet the conditions indicated in the present regulations since, for the purpose of the draw, they will be assigned a number, with numbering followed from the unit.

The identification of the competitors will be made through a list ordered by computer, where they will be listed:

- Sequential number automatically generated, by the computer system, for drawing purposes;
- Name of the 1st holder of the Card Account
- Current Account Number;
- Customer number
- Address
- Telephone contact (if any).

This contest will have 4 (four) draws, in which 4 (four) prizes will be awarded, consisting of 4 (four) travel vouchers of €1.000 (Euros) each.

The drawings will be made through spheres numbered 0 (zero) to 9 (nine), contained in a container intended for that purpose, from which as many spheres will be extracted as necessary to form the numbers that will indicate the winning numbers.

In each extraction, the 1st (first) sphere to come out will correspond to the number of units, the 2nd (second) will correspond to the number of tens, the 3rd (third) to the number of hundreds, and so on. If the number that comes out is not an assigned number, the drawing will be repeated.

For each prize one permanent Client and two substitute Clients will be drawn, in order of extraction. The first alternate will receive the prize in the absence of a claim or waiver by the permanent Client and the second alternate will receive the prize in the absence of a claim by the first alternate.

Each Client, effective or alternate, may enter the next month's draw, if he/she meets the defined invoicing criteria.

The winners will be contacted by ActivoBank by email/telephone within 5 (five) working days after the dates of each draw, mentioned in point 5.

5. Contest Rules:

This contest starts April 18th and ends August 31st, 2022 for all criteria.

4(four) travel vouchers of EUR 1000 each will be awarded.

Drawings will be held on the following dates:

- Qualification period from April 18th to May 31st, 2022 - 1st draw for 1 travel voucher on June 15th, 2022.
- Qualifying period June from 1st to 30th, 2022 - 2nd drawing for 1 travel voucher on July 13th, 2022.
- Qualifying period from 1st to July 31st, 2022 - 3rd draw for 1 travel voucher on August 17th, 2022.
- Qualifying period from August 1st to 31st, 2022 - 4th draw for 1 travel voucher on September 14th, 2022.

Place and Time of the Drawing:

The tabulation of participants and the determination of the winners will take place at Av Dr Mário Soares (Tagus Park), Edif 9, Piso 0, 2744 - 005 Porto Salvo, at 15h00, in the presence of representatives of the Ministry of Internal Administration.

The prizes are personal and non-transferable and are not redeemable for cash, regardless of the circumstance invoked.

6. Prize Claim:

Prizes must be claimed within 30 days from the date of the drawing at any Ponto Activo of ActivoBank, daily, except Sundays and Holidays, or through the Support Line, identifying and scheduling the date and Ponto Activo to deliver the prize.

In case the winner does not claim the prize during the period mentioned in the previous item, the first substitute will be informed within 5 working days from the deadline for claiming the prize. The first substitute must then claim the prize within 30 days from the Bank's communication.

If the first substitute does not claim the prize during the period referred to in the preceding paragraph, the second substitute will be notified within a maximum of 5 working days after the expiration date of the claim. The second substitute must then claim the prize within 30 days from the Bank's communication.

The prizes will be delivered to the winners at the place agreed upon between the parties for that purpose.

7. Publicizing the Tender:

The contest will be publicized on www.activobank.pt, the Bank being obliged, in compliance with the provisions of art. 11. of Decree-Law No. 330/90, of October 23, as amended by Decree-Law No. 275/98, of September 9, to clearly expose all the conditions concerning the same.

After the determination of the prize winners, the applicant is obligated to announce by the advertising means indicated in condition 7, the name and locality of their address, as well as the last day of the period in which the prizes may be picked up.
