

## **Campaign's General Conditions**

The campaign consists in the attribution of a voucher of 100€ (one hundred euros) for individual use in the hotel units belonging to the Discovery Hotel Management (DHM)

The Campaign is valid for ActivoBank Clients, individuals with legal age who, cumulatively, meet the following conditions:

a) Who domicile at ActivoBank their first salary or pension between **July 9<sup>th</sup> and October 15<sup>th</sup>**. By first salary, it is understood that on the ActivoBank's Current Account doesn't verify any salary or retirement pension credit in the last 12 months.

It is meant by domiciliation, the credited amount though a duly coded bank transfer, that is, with the code ISO "sala", "08" or "011".

b) That the domiciled salary or pension is equal to or greater than €1.250 net per month, excluding Holiday bonus, Christmas bonus or others. The calculation of the benefit will only be carried out after two consecutive months of receiving the eligible salary or pension amount in the Account.

c) Clients who don't have any of the following exclusion clauses:

o Incidents registered at Banco de Portugal;

o Who have already benefited from another commercial offer of the Bank, within the scope of salary domiciliation.

## **Voucher's Attribution Terms**

For the Accounts opened in joint ownership, it's given only one Voucher.

Vouchers are sent by the Bank to the Client, to the respective email address indicated in the Account.

The attribution will be held monthly, at the end of each month, and after referred previously in the document.

The Vouchers are personal and untransferable and cannot be converted into cash.

This Campaign is valid for 1.200 Vouchers. After depleting the stock of Vouchers, this fact will be disclosed on the Bank's public website.



## **Voucher's Utilization**

The DHM Vouchers can be used in any DMH Group Hotels and relatively for any services provided at the respective hotel unit, including accommodation or meals.

Regarding the use of the Voucher, if the value of the stay is lower than the Voucher, the remainder can be used in the unit's services.

The management of bookings and services is the exclusive responsibility of DHM Group and should be done through the email reservations@discoveryportugal.com. The Discovery Hotel Management Group units may be consulted through the Site <u>https://discoveryportugal.com/#</u>

At check-in, the Beneficiary must present the email sent by the Bank to confirm that he/she is the Voucher holder.

The Voucher is valid until December 31<sup>st</sup>, 2022, for use by the Customer, subject to the availability of each hotel unit in the Group.

The Voucher can only be used in one hotel unit.

The Voucher's acceptance is subject to the condition of salary domiciliation for 12 months, without which the value of the Voucher will be returned.

The ActivoBank and the DMH don't take responsibility for the misuse of Vouchers.

The Bank reserves the right to change or cancel the present campaign, without previous notice, whenever market conditions or any other relevant conditions thus determine.
